## Sample Wording for a Will

The following are examples of language to consider for leaving a bequest to the Foundation

### Specific Bequest

“TO PAY the following legacy as soon as conveniently possible after my death:

- the sum of \$\_\_\_\_\_ in cash or in kind to JOSEPH BRANT HOSPITAL FOUNDATION to be used to support the highest priorities as determined by the Board of Directors of the Foundation.”

### Residual Bequest

“TO DIVIDE the residue of my estate into as many equal shares as may be necessary to give effect to the following provisions and to distribute such shares to the following organization:

- One (1) share to JOSEPH BRANT HOSPITAL FOUNDATION to be used to support the highest priorities as determined by the Board of Directors of the Foundation.”

### Power to Vary Provision

In order to ensure that your contribution is utilized according to your wishes with the maximum amount of flexibility, you may also wish to include this “Power to Vary” provision:

“If, in the opinion of the Board of Directors of JOSEPH BRANT HOSPITAL FOUNDATION, it should become impossible, inadvisable, or impractical to use this gift for the purposes of supporting \_\_\_\_\_, then the Board may in its discretion use the gift to the best advantage of JOSEPH BRANT HOSPITAL FOUNDATION, keeping in mind the original wishes of the donor.”

## Tax Benefits

Canada Revenue Agency provides tax credits for gifts to eligible charitable organizations such as the Joseph Brant Hospital Foundation. You can claim up to 75% of your net income in charitable donations each year and can in some cases carry forward unused tax credits for up to five years.

### Gifts of Cash (multi-year pledges, monthly gifts and one-time gifts)

The chart below represents the approximate combined federal and provincial non-refundable tax credits that may be realized through charitable donations of cash.

Total donated per year	21.05%* tax credit on first \$200 donated	40.16%* credit on remaining donation	Total Tax Credit	Actual cost to donor
\$1,000	\$42.10	\$321.28	\$363.38	\$636.62
\$5,000	\$42.10	\$1,927.69	\$1969.78	\$3,030.22
\$10,000	\$42.10	\$3,935.68	\$3,977.78	\$6,022.22
\$25,000	\$42.10	\$9,959.68	\$10,001.78	\$14,998.22

\* 21.05% credit on first \$200 donated constitutes 15% federal and 6.05% provincial tax credits

\*\* 40.16% credit on remaining donation constitutes 29% federal and 11.16% provincial tax credits

*As of February 2014, a Stretch Tax Credit may also be available increasing the eligible federal tax credits by an additional 10% (25% and 39% respectively) on your first \$10,000 in donations.*

Note: if you have not made a charitable donation before (or since 2007). You may also be eligible for the *First Time Donor's Super Credit* (25%) on your first \$1,000 in eligible donations.

### Gifts of Stocks and Securities

In 2006, the federal government removed the capital gains tax on stocks and securities donated to registered charities. This means you can significantly decrease the after-tax cost of giving and receive an official tax receipt for the full market value of the stock on the day it is received and sold.

The following example illustrates the benefit of giving stocks to make a charitable contribution versus selling the stock personally and donating the realized cash to charity.

	Cash gift after sales of shares	Gift of shares to charity (capital gains tax exempt)
Value of stock at time of sale or transfer (a)	\$100,000	\$100,000
Initial value of stocks (b)	\$20,000	\$20,000
Capital gain (c) $c = a - b$	\$80,000	\$80,000
Tax on capital gains (d) $d = (c \times 50\%) \times 46\%^*$	\$18,400	\$0
Donation tax credit (e) $e = a \times 46\%^*$	\$46,000	\$46,000
Net tax saving from donation $e - d$	\$27,600	\$46,000

\* Assumes gift made in Ontario with a marginal tax rate of 46%.
